Dickenson County will reopen its offices under a normal work schedule (8:30am – 4:30pm) on Monday June 1, 2020. However, due to the continued coronavirus pandemic, we will do so with several restrictions.

- **PAYMENT OF JUNE 5 REAL ESTATE TAXES:**
 - The Dickenson County Treasurer office will remain closed to the public until at least June 10. However, a public payment area for cash payments only will be setup in the foyer of the Dickenson Center for Education and Research (DCER). Please see the attached statement from the Treasurer for details
- Outside building doors will be opened and closed on the above time schedule daily; at the DCER, ONLY the front foyer public door will be unlocked at this time
- **Governor Executive Order 63 requires everyone wear face coverings while inside public buildings;** in addition, we continue to ask you adhere to social distancing of a minimum of six feet between guests and no more than 10 individuals allowed in any one area
- Public access to specific department offices will be limited and may be by appointment only in many instances, until further notice. We ask that you contact the specific county department by phone or email first to see if your business can be handled in that manner or if an appointment needs to be scheduled
- All Dickenson County offices reserve the right to **NOT** serve customers who display any form of illness or will not follow EO63 guidelines. If you feel ill and have business with one of our offices, please do not come to our offices but call to make arrangements for your transaction or send a healthy person in your place
- We are still working on Plexiglas installation in many public areas for the continued safety of our staff and ask that you bear with us during this process
- Dickenson County Board of Supervisors meetings and workshops will continue to be held but will remain in accordance with the limited public gathering requirements of 10 and EO63 guidelines until such restrictions are lifted by the Governor
